**A BILL TO AMEND BILL NO. 1474 TO AMEND THE APPROPRIATION FOR IMPROVEMENTS TO AIRPORT ROAD**

WHEREAS Bill No. 1474 authorized the improvement of Airport Road.

NOW, THEREFORE, BE IT ENACTED BY the County Council of Talbot County, Maryland, as follows:

SECTION 1: The improvement of Airport Road is hereby authorized as a capital project. The scope of work includes, but is not limited to, surveying and right-of-way acquisition for the future design, engineering, property acquisition, drainage improvements, and construction and widening of Airport Road between Maryland Rt. 50 and Goldsborough Neck Road in order to improve traffic safety. Approval of this capital project includes authorization to expend funds, not to exceed the total amount of the appropriation, for all incidental and customary costs and charges associated with and reasonably necessary for design, engineering, construction and completion of the project.

SECTION 2: The County Council of Talbot County (the "County Council") is hereby authorized to expend up to \$2,900,000 for the Airport Road project. The project will be funded by Development Impact Fees of approximately \$700,000, funds from the Capital Projects Fund of approximately \$1,450,000, and Cost Sharing funds of \$750,000. Acceptance of federal and State grant funds, the use of cost sharing funds received by the County for this project, Development Impact Fees, and the use of funds in the Capital Projects Fund is authorized. The County Council is authorized to use federal and State grants, cost sharing funds received by the County for this project, Development Impact Fees, and funds in the Capital Projects Fund or a combination of federal and State grants, cost sharing funds received by the County, Development Impact Fees, and funds in the Capital Projects Fund not to exceed \$2,900,000 for this project. This represents an increase of \$1,200,000 over prior authorizations. The increase is funded by additional Capital Projects funds of \$1,200,000.

SECTION 3: This Bill will take effect sixty (60) calendar days from the date of enactment.

SECTION 1: The connection of the Bar Neck and Fairbank communities to the Region V (Tilghman) Wastewater Treatment Plant is hereby authorized as a capital project. The scope of work includes, but is not limited to, the design, engineering, property acquisitions and construction of a sewer collection and pumping systems to connect the residences and businesses located in Bar Neck and Fairbank communities to the Region V (Tilghman) Wastewater Treatment Plant. Approval of this capital project includes authorization to expend funds, not to exceed the total amount of the appropriation, for all associated transactional costs and for incidental and customary costs and charges associated with and reasonably required for financing, planning, design, construction, and completion of the project

SECTION 2: The County Council of Talbot County is hereby authorized to expend up to \$2,190,000 for the completion of this project. The project will be funded by grants, if awarded, and by long-term borrowing not to exceed \$2,190,000. This represents an increase of \$190,000 over prior authorizations. The increase is funded by additional federal and State grants, if awarded or by Long Term Borrowing of \$190,000. Acceptance of federal and State grants for this capital project is hereby authorized. Borrowing to finance this capital project for this project is hereby authorized. All costs incurred for this capital project shall be repaid from revenues generated from fees paid by the users of this sewer collection system.

SECTION 3: This Bill will take effect sixty (60) calendar days from the date of enactment.

## **A BILL TO AUTHORIZE IMPROVEMENTS TO COUNTY BRIDGES**

BE IT ENACTED BY the County Council of Talbot County, Maryland, as follows:

SECTION 1: Repair and maintenance improvements to County bridges are hereby authorized as a capital project. The scope of work includes, but is not limited to, design, development of construction bid documents and construction management to above and below water surface improvements to selected County bridges, as required, based on the National Bridge Inspection Standards (NBIS) inspection program, and other repairs and maintenance, including the upgrade of traffic barriers to selected County bridges. Approval of this capital project includes authorization to expend funds, not to exceed the total amount of the appropriation, for all associated transactional costs and for incidental and customary costs and charges associated with and reasonably required for planning, design, construction, and completion of the project.

SECTION 2: The County Council of Talbot County is hereby authorized to expend up to \$216,147 for the repair and maintenance improvements to County bridges. The project will be funded by approximately \$216,147 in funds from the Capital Projects Fund.

SECTION 3: This Bill will take effect sixty (60) calendar days from the date of enactment.

NOW, THEREFORE, BE IT ENACTED BY the County Council of Talbot County, Maryland, as follows:

SECTION 1: The expansion of Broadband to unserved and underserved areas of Talbot County is hereby authorized as a capital project. The scope of work includes, but is not limited to, partnering with Easton Utilities Commission to provide the infrastructure to expand Broadband to the unserved and underserved areas of Talbot County. Approval of this capital project includes authorization to expend funds, not to exceed the total amount of the appropriation, for all associated transactional costs and for incidental and customary costs and charges associated with and reasonably required for planning, design, construction, and completion of the project.

SECTION 2: The County Council of Talbot County is hereby authorized to expend up to \$4,062,000 for the expansion of Broadband to unserved and underserved areas of Talbot County. Acceptance of federal and State grant funds, the use of Franchise Fees received by the County for cable television service, and the use of funds in the Capital Projects Fund is authorized. The County Council is authorized to use federal and State grants, Franchise Fees or Capital Projects funds, or a combination of federal and State grants, Franchise Fees and Capital Project funds not to exceed \$4,062,000 for this project. This represents an increase of \$1,750,000 over prior authorizations. The increase is funded by additional federal and State grants of \$1,750,000.

SECTION 3: This Bill will take effect sixty (60) calendar days from the date of enactment.

This represents an increase of \$200,000 over prior year authorizations. The increase is funded by additional funds from the Capital Projects Fund of \$200,000.

SECTION 1: The acquisition, renovation and/or construction of Emergency Medical Services (EMS) Stations for the northern and Bay Hundred areas of Talbot County is hereby authorized as a capital project. The scope of work includes, but is not limited to, acquisition of a site and/or building, the planning, design, preparation of construction/renovation documents, the construction/renovation of the facilities and equipping of EMS stations for the northern and Bay Hundred areas of Talbot County. Approval of this capital project includes authorization to expend funds, not to exceed the total amount of the appropriation, for all associated transactional costs and for incidental and customary costs and charges associated with, and reasonably required for, acquisition, planning, design, engineering, construction/renovation and equipping necessary for the completion of the project.

SECTION 2: The County Council of Talbot County is hereby authorized to expend up to \$2,205,000 in funding from the Capital Projects Fund for this project.
