WHEREAS, Bill Nos. 1393, 1452, and 1480 authorized the development of the Frederick Douglass Park on the Tuckahoe.

NOW, THEREFORE, BE IT ENACTED BY the County Council of Talbot County, Maryland, as follows:

SECTION 1: The development of the Frederick Douglass Park on the Tuckahoe is hereby authorized as a capital project. The scope of work includes, but is not limited to, the planning, design and construction of park assets, scenic overlook platforms and an interpretive kiosk. Approval of this capital project includes authorization to expend funds, not to exceed the total amount of the appropriation, for all incidental and customary costs and charges associated with, and reasonably necessary for, design, engineering, construction and completion of the project.

SECTION 2: The Talbot County Council is hereby authorized to expend up to \$1,000,000 for this project. Acceptance of federal and State Grants for this capital project is hereby authorized. This project will be funded by approximately \$726,000 in federal and State grants and \$274,000 of funds from the Capital Projects Fund. This represents an increase of \$500,000 over prior authorizations. The increase will be funded by additional federal and State grants of \$500,000.

SECTION 3: This Bill will take effect sixty (60) calendar days from the date of enactment.

**A BILL TO AMEND BILL NO. 1516 FOR THE PURPOSE OF AMENDING THE APPROPRIATION FOR IMPROVEMENTS TO AND EXPANSION OF THE ST. MICHAELS BRANCH OF THE TALBOT COUNTY FREE LIBRARY**

WHEREAS, Bill No. 1516 authorized the architectural and engineering fees associated with the renovation of the St. Michaels Branch of the Talbot County Free Library.

NOW, THEREFORE, BE IT ENACTED BY the County Council of Talbot County, Maryland, as follows:

SECTION 1: Improvements to and expansion of the St. Michaels Branch of the Talbot County Free Library is hereby authorized as a capital project. Prior authorization for this project included, but was not limited to, the planning, design and preparation of construction documents for the renovation of the St. Michaels Branch of the Talbot County Free Library. The scope of work is hereby extended to include, but will not be limited to, design, completion and construction of the expansion and renovation of the St. Michaels Branch of the Talbot County Free Library. Approval of this capital project includes authorization to expend funds, not to exceed the total amount of the appropriation, for all associated transactional costs and for incidental and customary costs and charges associated with, and reasonably required for, planning, design and completion of the project.

SECTION 2: The County Council of Talbot County is hereby authorized to expend up to \$719,600 for this project. Acceptance of federal and State grant funds is hereby authorized. The County Council is authorized to utilize a combination of federal and State grants, funds from the Capital Projects fund, and Development Impact Fees not to exceed \$719,600 for this project. This project will be funded by approximately \$359,800 of federal and State grants, \$245,000 from the Capital Projects Fund, and \$114,800 from Development Impact Fees. This represents an increase of \$674,600 over prior authorizations. The increase will be funded by additional federal and State grants of \$359,800, \$200,000 of which is from the Capital Projects Fund, and \$114,800 in Development Impact Fees.

SECTION 3: This Bill will take effect sixty (60) calendar days from the date of enactment.

SECTION 1: The purchase of improved or unimproved real property for future County purposes is hereby authorized as a capital project. The scope of work includes, but is not limited to, the purchase of improved or unimproved real property, including any associated fees, title work and land surveys, and, if long-term borrowing is utilized, the cost of issuance of any bonds or other long-term borrowing needed to finance the project. Approval of this capital project includes authorization to expend funds, not to exceed the total amount of the appropriation, for all associated transactional costs and for incidental and customary costs and charges associated with, and reasonably required for, the acquisition of improved or unimproved real property.

SECTION 2: The Talbot County Council is hereby authorized to utilize either long-term borrowing or Capital Projects funds, or a combination of long-term borrowing and Capital Projects funds, not to exceed \$6,100,000 for this project. This represents an increase of \$2,000,000 over prior authorizations. The increase will be funded by additional funds from the Capital Projects Fund of \$2,000,000.

SECTION 3: This Bill will take effect sixty (60) calendar days from the date of enactment.

SECTION 1: The upgrade or replacement of the wastewater treatment plant at The Preserve at Wye Mills is hereby authorized as a capital project. The scope of work includes, but is not limited to, the design, engineering and construction of a Membrane Bioreactor (MBR) wastewater treatment system to upgrade or replace the wastewater treatment plant utilized by the sixty-seven (67) lot community of The Preserve at Wye Mills. Approval of this capital project includes authorization to expend funds, not to exceed the total amount of the appropriation, for all incidental and customary costs and charges associated with, and reasonably necessary for, completion of the project and the cost of issuance of any bonds needed to finance the project.

SECTION 2: The Talbot County Council is hereby authorized to expend up to \$1,550,000 for the project. Borrowing to finance this capital project and acceptance of federal and/or State grant funds for this project is hereby authorized. This project will be funded by approximately \$650,000 of federal and State grants and \$900,000 of funds from long-term borrowing. This represents an increase of \$800,000 over prior year authorizations. The increase will be funded by additional federal and State grants of approximately \$400,000 and \$400,000 from long-term borrowing. All costs incurred for this capital project shall be repaid by the users of the wastewater treatment system at The Preserve at Wye Mills.

SECTION 3: This Bill will take effect sixty (60) calendar days from the date of enactment.
