

TALBOT COUNTY, MARYLAND

County Council MINUTES June 25, 2024

Present – President Chuck Callahan, Vice President Pete Lesher, Keasha N. Haythe, Lynn L. Mielke, County Manager Clay Stamp, and County Attorney Patrick Thomas. Council Member Dave Stepp was absent.

- I. <u>Agenda</u> Mr. Callahan requested and received unanimous consent for approval of the Agenda of Tuesday, June 25, 2024.
- II. <u>Minutes</u> Mr. Callahan requested and received unanimous consent for approval of the Minutes of Tuesday, May 14, 2024.
- III. <u>Disbursements</u> Mr. Callahan requested and received unanimous consent for approval of the Disbursements of Tuesday, June 18, 2024, and Tuesday, June 25, 2024.
- IV. Certificate of Recognition to Talbot Agriculture and Education Center for 60th Anniversary The Clerk read a certificate of recognition into the record which spoke of the establishment of the Talbot Agriculture and Education Center in 1964 for the purpose of strengthening and preserving Talbot County's rural culture through the hosting of events for agriculturally oriented organizations including Talbot County 4-H, Talbot County Farm Bureau and the Easton Future Farmers of America (FFA), as well as various civic organizations in Talbot County. For the past 41 years, the Talbot Agricultural and Education Center has hosted the Talbot County Fair. Council discussion ensued with representatives of the agricultural community in attendance. Upon motion by Ms. Mielke, seconded by Mr. Lesher, the Council approved the certificate of recognition by voting 4-0 0 as follows:

Ms. Haythe presented the Certificate of Recognition to representatives of the various organizations in attendance.

V. Request from Talbot County Public Schools for FY24 Categorical Budget Transfers – Sarah Jones, CPA, Chief Financial Officer, Talbot County Public Schools; Dr. Sharon Pepukayi, Superintendent, Talbot County Public Schools – Ms. Jones stated that Talbot County Public Schools recently received its final FY25 budget appropriation from the County and is requesting Council approval to amend the FY24 budget by making the following Categorical Budget Transfers through a savings in the following categories: \$850,000 in the Instructional Salaries category; \$400,000 in the Special Education category; and \$100,000 from the Operating Fund to the Capital Projects Fund from the White Marsh Elementary School roof project which was completed significantly under budget. She stated that the Categorical Transfers are needed in the following categories: \$25,000 to Administration to cover additional legal costs; \$45,000 to Mid-Level Administration (principals,

assistant principals, curriculum supervisors and directors) to cover professional learning registrations from an overage in the salary line; \$80,000 to Other Instructional Costs for additional instructional software; \$75,000 to Student Services to prepay costs for software originally included in the FY25 budget and to cover instruction of students who are unable to come to school; \$500,000 to Transportation for prepayment of bus lease payments originally included in the FY25 budget; \$350,000 to Operation of Plant to cover overages related to same; repairs, and to purchase advance supplies; \$100,000 in Maintenance of Plant to cover overages and repairs; and \$600,000 to Fixed Charges to prepay health insurance premiums originally included in the FY25 budget and to prepay the OPEB (Other Post Employment Benefits) for FY25. Council discussion ensued with Ms. Jones and Dr. Pepukayi as various items were brought forward, including recruitment and retention of staff, which Ms. Jones and Dr. Pepukayi emphasized was a priority. Upon motion by Mr. Lesher, seconded by Ms. Mielke, the Council approved the categorical budget transfers as requested by voting 4-0 as follows:

VI. <u>Introduction of Legislation</u>:

A BILL TO AUTHORIZE THE REPLACEMENT AND IMPROVEMENT OF THE CART BRIDGE AT THE NINTH HOLE OF THE TALBOT COUNTY HOG NECK GOLF COURSE was read into the record by the Clerk and brought forward for introduction. Martha Sparks, Finance Director, stated that the legislation was inadvertently omitted when other capital enabling legislation was introduced on Tuesday, June 11, 2024. The legislation was introduced by Mr. Callahan, Mr. Lesher, Ms. Mielke, and Ms. Haythe as Bill No. 1575. A public hearing was scheduled for Tuesday, July 23, 2024, at 5:30 p.m. in the Bradley Meeting Room, South Wing, Talbot County Courthouse, 11 North Washington Street, Easton, Maryland 21601.

VII. County Manager's Report:

A. <u>Talbot County Animal Control Board</u> – Requested Council approval for the reappointment of Karla Wieland-Cherry to a three-year term on the Talbot County Animal Control Board as a representative with knowledge pertinent to the Board's functions; said term will expire on July 1, 2027. Upon motion by Mr. Lesher, seconded by Ms. Haythe, the Council approved the reappointment by voting 4 – 0 as follows:

B. Talbot County Golf Board – Requested Council approval for the appointment of Dana Eggert to a three-year term on the Talbot County Golf Board; said term will expire on June 1, 2027. Upon motion by Ms. Haythe, seconded by Ms. Mielke, the Council approved the appointment by voting 4 – 0 as follows:

C. Talbot Family Network Board of Directors – Requested Council approval for the reappointment of Berenice Orellana and the appointment of Katie Fox to three-year terms on the Talbot Family Network Board of Directors as representatives of the private sector; said terms will expire on June 30, 2027. Upon motion by Mr. Lesher, seconded by Ms. Haythe, the Council approved the reappointment and appointment by voting 4-0 as follows:

D. <u>Talbot County Tourism Board</u> – Requested Council approval for the appointment of Town of St. Michaels Commissioner David Wojciechowski to a four-year term on the Talbot County Tourism Board as a representative of the Town of St. Michaels; said term will expire on July 1, 2028. Upon motion by Mr. Lesher, seconded by Ms. Haythe, the Council approved the appointment by voting 4 – 0 as follows:

E. Request from Facilities Maintenance – Requested Council approval of the recommendation of the Superintendent of Roads and County Facilities to award a contract for electrical upgrades to the transformer which provides electrical service to the main and north wing portions of the Talbot County Courthouse and the State's Attorney's building to the lowest proposer, Fluharty's Electric, in the sum of \$65,324: funding for the project was included in the County's FY24 Budget. Council discussion ensued with Brian Moore, Superintendent, Roads and County Facilities, who outlined the necessity for the project. Upon motion by Ms. Mielke, seconded by Ms. Haythe, the Council approved the award by voting 4 – 0 as follows:

F. Request from Department of Emergency Services - Requested Council approval of the recommendation of the Director of the Department of Emergency Services to award the contract for the rewrite of the County's Continuity of Operations Plan (COOP) to Tetra Tech in the sum of \$62,059.00; funding for the rewrite will come from Emergency Management Preparedness Grant (EMPG) funding. Brian LeCates, Director, Department of Emergency Services, stated that the purpose of the update is to ensure all Talbot County departments are able to continue to perform essential functions in the

event of a natural or manmade disaster. Upon motion by Ms. Haythe, seconded by Mr. Lesher, the Council approved the award by voting 4-0 as follows:

G. Request from Finance Office to Approve 4th Quarter Budget Transfers for Fiscal Year 2023-2024 – Martha Sparks, Finance Director, stated that § 615 of the Talbot County Charter provides for transfers between agencies of the County government and within the same fund only during the last quarter of the fiscal year, upon the recommendation of the County Manager and the approval of the County Council. She stated that the budget transfer for which she is requesting approval focuses on a transfer of remaining contingency funds toward a contribution to the County's investment with the Maryland Association of Counties (MACo's) Other Post Employment Benefits (OPEB) Fund. She stated that the County provides post-retirement healthcare benefits under the County's retiree plan and investment in the MACo OPEB Fund mitigates the liability associated with providing future benefits to our retirees; and for a transfer to move additional operating appropriations between categories; total transfers between categories is \$628,428. Council discussion ensued with Ms. Sparks. Upon motion by Mr. Lesher, seconded by Ms. Haythe, the Council approved the budget transfers as outlined by voting 4 – 0 as follows:

H. Request from County Manager to Enter into an Easement Agreement with Timothy and Cynthia Nolan for the Bozman/Neavitt Sewer Extension Project – Requested Council approval to enter into an easement agreement with Timothy and Cythia Nolan, owners of property in the Mt. Pleasant area of St. Michaels. Mr. Stamp stated that if approved, it would allow the contractor for Resolution No. 250 construction project to directionally drill on their property approximately 40 feet down, go under Broad Creek and come back onto the ground on Scotts Lane (St. Michaels); he outlined basic provisions included in the easement agreement. Council commended staff for reaching an agreement for this important step in the project. Upon motion by Mr. Lesher, seconded by Ms. Mielke, the Council approved the Easement Agreement by voting 4 – 0 as follows:

VIII. Public Hearings:

Resolution No. 358, A RESOLUTION TO FORMALLY CLOSE SEGARS CORNER ROAD AS A COUNTY ROAD AND AUTHORIZE THE CONVEYANCE THEREOF TO THE UNDERLYING

FEE SIMPLE OWNERS, was read into the record by the Clerk and brought forward for public hearing. Prior to the public hearing, County Attorney, Patrick Thomas, stated that the Segars Corner Road is a very short road which is an alternate connector between Lewistown Road and Coveys Landing Road. He stated that the roadway is in very bad condition and would require significant expense to upgrade and maintain to County road standards; the resolution proposes to abandon the road and convey the underlying land to the property owners on each side. Members of the public were then afforded an opportunity to comment on the legislation. The Council approved Resolution No. 358 by voting 5-0 as follows:

Resolution No 359, A RESOLUTION TO PLACE A QUESTION ON THE BALLOT AT THE NOVEMBER 2024 GENERAL ELECTION TO AMEND § 614 OF THE CHARTER OF TALBOT COUNTY TO ALLOW, BUT NOT REQUIRE, THE COUNTY COUNCIL OF TALBOT COUNTY TO ADD UP TO ONE CENT (1¢) PER ONE HUNDRED DOLLARS OF ASSESSED VALUE ABOVE THE REVENUE CAP FOR AN ADDITIONAL FIVE (5) YEARS BEGINNING JULY 1, 2026, was read into the record by the Clerk and brought forward for public hearing. Prior to the public hearing, County Attorney, Patrick Thomas, stated that the purpose of the proposed Charter amendment outlined in Resolution No. 359 would extend the provisions of the Charter amendment outlined in Resolution No. 288 approved by the voters of Talbot County at the 2020 General Election for another five (5) years, beginning July 1, 2026; revenues raised would be used for Public Safety. Mr. Thomas stated that Resolution No. 288 permitted, but did not require, the Council to add up to one cent (\$.01) per \$100 of assessed value above the revenue cap for a period of five (5) years, beginning July 1, 2021. Mr. Lesher stated that he wished to introduce an amendment to Resolution No. 359, originally offered by Mr. Stepp, which would extend the provisions for seven (7) years instead of five (5) so that the provisions would expire in a presidential election year when the ballot is less crowded, instead of a Councilmanic election year, when the ballot is crowded. The amendment, known as Amendment No. 1, was introduced by Mr. Callahan, Ms. Haythe, Mr. Lesher, and Ms. Mielke. Members of the public were then afforded an opportunity to comment on Resolution No. 359 and Amendment No. 1. Martha Sparks, Finance Director, stated that the additional one cent (\$.01) has augmented funding to provide 26 positions to date, including paramedics, School Resource Officers (SROs) EMTs, 9-1-1 Operators, and supplemental retirement programs - Law Enforcement Officers Pension System (LEOPS) and Correctional Officers Retirement System (CORS), vehicles and increased funding for the county's volunteer fire departments. The Council approved Amendment No. 1 by voting 5-0 as follows:

Resolution No. 359, as amended, was then brought forward for vote. The Council approved Resolution No. 359, as amended, by voting 5-0 as follows:

Resolution No. 359, as amended, will be submitted to the voters of Talbot County at the 2024 General Election.

IX. **Public Comments:** There were no public comments.

X. Council Comments:

Mr. Lesher -

Mr. Lesher stated that earlier in the evening the Council had heard from the Talbot Agriculture and Education Center which sponsors 4-H and, in his opinion, contributes to really important enrichment and character building. He stated that the County's Parks and Recreation Department is also running its summer camp programs at the Talbot County Community Center and that he had recently come back from a week of scout camp with the Boy Scouts, another character-building organization. He stated that there are so many organizations in our community that are doing youth enrichment, character building and various youth programming and, in his opinion, this is the season when programming becomes so important as schools are out. He expressed his appreciation to the professionals and the volunteers in the various organizations engaged in providing programming for doing this work in the community.

Ms. Mielke

Ms. Mielke stated that Easton Airport is sponsoring a summer learning activity program for children ages 12 to 16 where they learn about airfield design, model rocket construction, make a paper airplane and launch a model rocket. She encouraged those interested to get additional information on eastonairport.com or on the County's website talbotcountymd.gov. Ms. Mielke concluded her comments by stating that, in her opinion, it is a great opportunity for students to learn about aviation and to possibly pursue aviation as a career.

Ms. Haythe -

Ms. Haythe concurred with the comments of Mr. Lesher and Ms. Mielke, stating that this is the time for our young people that are out of school to take advantage of summer enrichment opportunities and encouraged parents and families to do so. She stated that she hoped everyone has a happy, safe 4th of July holiday as they celebrate with family, friends and loved ones.

Mr. Callahan - Mr. Callahan stated that he hoped everyone has a fun 4th of July and reminded everyone that because of dry conditions in the area, the County put a ban on open burning and personal fireworks. He stated that the Council wants everyone to have fun but to use common sense and wait for rain before again using fire pits, etc. Mr. Callahan concluded his comments by expressing his appreciation to Konner Metz, reporter for *The* Star Democrat, for covering the Council's meetings.

Upon motion by Ms. Haythe, seconded by Ms. Mielke, the Council voted to adjourn and to reconvene on Tuesday, July 9, 2024, at 2:30 p.m. for a work session on the proposed Frederick Douglass Bike Trail in Talbot County, to convene in Open Session at 3:30 p.m. and immediately adjourn into Closed Session as listed on the statement for closing that meeting, and for the regularly scheduled meeting at 5:00 p.m. by voting 4-0 as follows:
