SECTION 2: The Talbot County Council is hereby authorized to expend up to \$629,000 in for this project. The project will be funded by federal and State grants of approximately \$114,000 and funding from the Capital Projects Fund of approximately \$515,000 for this project. Acceptance of federal and State Grants for this capital project is authorized. This represents an increase of \$300,000 over prior authorizations. The increase is funded by additional funds from the Capital Projects Fund of \$300,000.
